OLD WOUGHTON PARISH COUNCIL

Hello again from all the team and we really do mean - again! Since the Spring edition, the parish elections postponed from May 2020 have been held and eight of the nine retiring members are back in harness, with a process underway to Co-opt a replacement for Jeremy Morrison for the Passmore ward. All the details are on page 2, including the revised list of responsibilities agreed at May's AGM.

It's also a case of new beginnings for our Chair, as she starts out on her first full year in office. Charlotte talks about a "new pencil case, new notebook and a new horizon" in her column opposite and also shares the very good news of her election to Milton Keynes Council representing the whole Campbell Park and Old Woughton ward – anyone with two photographs in Old Woughton News deserves our gratitude - thank you so much Cllr. Hall!

Our Centrefold feature is also about beginning afresh and, as signalled last time, the new Council is already turning its thoughts to the parish finances. We urge you to spend a little time on the budget survey on page 8 to help inform our discussions about the 2022/23 draft budget and the Precept required to meet parishioners' vision for our local area. In something of a plot spoiler, the investment of the reserves inherited back in 2012 is drawing to a close and we now need collectively to agree whether that's 'job done' or whether to keep up the pace and raise more funds to support a greater range of projects. The graph re-produced on page 4 captures how very economical OWPC is to run even in comparison to our neighbouring parishes, but it's your views that will shape the final decision, so do please respond on-line at https://oldwoughton.org.uk/survey/ or by using the tear-off survey sheet and posting it through your councillor's door.

An altogether more joyous beginning, however, is the ability to socialise again with friends and neighbours and in the warmer summer months a host of outdoor activities beckon (see page 6 for some new initiatives). Frustratingly, litter-picking is a perennial commitment and new dates are published for each of the four wards, but even this can lift spirits and we hear from one of our young people on the sense of achievement a good clear-up can bring. Maybe we can tempt you to join us?

Well here we are! You have a new parish council team who have been formally elected - seven of us unopposed. We are so very, very lucky to have such committed volunteers stepping forward to take on the responsibilities of Parish Councillors - the first tier of local government. We say goodbye (and huge thanks) to Jeremy Morrison, who is moving away, but we are already working with a resident from Passmore with a view to Co-option, which would make us complete again — to the envy of many of our neighbouring councils (eg Simpson & Ashland have 50% vacancy).

As we start our new 3-year terms of 'office', it somehow feels like the start of a new school year: new pencil case, new notebook and a new horizon! In our last edition, we reflected on how we had evolved as a completely new Parish Council and the financial mechanics of the Precept and the details of how we function. We now look to you, our residents, to help us shape the next era of your parish council.

It seems that the themes of the day are about involvement, engagement and strategy and how we bring those together in the further interests of Old Woughton. Co-incidentally, I took the personal decision to get even more involved by running a campaign for MKC Ward Councillor and now I find have two pictures on page 2 having also been elected on the 6th May for Campbell Park and Old Woughton - a rich reward indeed and a huge privilege! I believe this will come to be recognised as yet more tools in our box, as I will be able to get closer to gaining information and finding solutions from the higher tier of local government.

Crucially, I remain very much rooted in local issues and would like to know what matters to YOU? So, it is most fitting that this Newsletter carries our first survey on OWPC's financial approach going forward. I would encourage you to complete our survey on pages 7 and 8 so we can truly hear and understand your local voice.

Decisions, Decisions



In the Spring edition, we looked at how OWPC fits into the arrangements for local government nationally and, specifically, how it is financed to deliver its role as a first tier authority. We also reported that there were upcoming elections to the PC on the 6th May and the newly-elected councillors are now looking to their programme of work leading up to setting the draft budget for public consultation in the Autumn.


Your feedback is very important in helping shape that debate, but we realise that local government finance isn't for everyone and so we thought we should scope out some alternative models about what sort of parish council we want to fund going forward. In the very beginning...

Let's start with a little context. After its creation on 1st April 2012, OWPC adopted a statement designed to capture its distinctive spirit or ethos, which has guided us ever since:

The early years

As we read in the last issue, OWPC came into being with a precept levied by our previous local authority which meant our first precept amounted to a total of £59,931. The precept amount levied was halved in the following year and by the third year it was reduced to a total of £9,104. Thereafter, in keeping with our ethos, it was decided firstly to keep the precept amount unchanged (i.e. no inflationary uplift); and, secondly, to safeguard these monies in a general reserve whilst we learned how to manage the new parish effectively. The graph on page 8 of the Spring edition shows OWPC spending as one of the very lowest across the whole of the borough of Milton Keynes and noticeably less than our immediate neighbours:



OUR ETHOS: COMMUNITY - SERVICE - ECONOMY

Our ethos is thus strongly embedded in the local community which is evidenced by the large numbers of residents who regularly turn out to PC meetings. We are highly service-orientated, acting promptly and appropriately to ensure our responsibilities are fully discharged in the best interests of its residents. We are passionate about preserving, enhancing and protecting our beautiful, semi-rural environment. In the wider realm we work enthusiastically with Milton Keynes Council, The Parks Trust, neighbouring parishes and other bodies. In addition to doing our business effectively and efficiently, we are also determined to do it economically and overall to give the very best value for money. To this end we maintain the very lowest, operational cost base that we can and our financial affairs are completely transparent and accountable.

Growing more confident

Incredibly, to us at least, OWPC will be 10 years old next April - it has taken all this time to invest those opening Reserves. However, from 2022/23, we have to decide what level of spend we want to make available to facilitate new requests for parish council services. We clearly understand what our operational costs are so this seems a good time to engage in a consultation about what sort of parish council you, our residents, would like.

The Reserves

On its creation, OWPC inherited the equivalent of its annual Precept as a cash Reserve, but the size of this reserve was commented upon by the External Auditor in terms of best practice. Since 2012, OWPC has both reduced the size of its Precept, to a level below that required to cover all operational costs, whilst investing in a series of small, local projects. This has been undertaken in order to reduce the size of the inherited Reserves to a level in keeping with best practice in relation to our operational needs. Our Reserves policy currently requires us to retain £18.5k in Reserves.

The Precept

If the Parish Council continues to operate as now, but with no capital projects, such as the defibrillator in Turpyn Court, planting trees on Baskerfield Grove or landscaping in Woughton Park and Passmore, there would still be a need to increase the precept, to compensate for the loss of **subsidy to running costs**. Currently there are only five parishes of the 48 parishes in Milton Keynes, whose precept for a Band D Council Tax payer, is less than that in Old Woughton. In real terms it would mean a Band D Council Tax payer would pay another £12.91 per year in addition to the current amount of £21.83. That is little more than £1 per month.

Decision Time

Would you like a parish council that does only the minimum required to meet statutory requirements; or would you prefer one that attempts to improve our parish environment and engender a sense of community; or something in between?

In the Spring edition, we set out the four main roles that OWPC currently fulfills on your behalf and whilst Governance is now largely set from our experience, the other three activity areas are completely discretionary viz:



GOVERNANCE (basic model)

This includes all things we must do like employing the Clerk; Audit, IT and Insurance costs; holding public meetings with residents; and responding to the consultations from other public bodies, notably the Planning Authority. **Approx.** 70% of annual spend.

ENCOURAGING VOLUNTEERING

(optional)

All nine of your parish councillors are volunteers and claim no allowances, as we are happy to make our skills and experience work for the benefit of Old Woughton. We also try to facilitate opportunities for other neighbours to become involved (for example litter-picking; towpath repairs; and landscape improvements).

Costs are negligible - 0% in 2021/22.





OWPC has styled itself as a very open and communicative council with a physical Noticeboard in each of the four wards; targeted leaf-letting; a quarterly Newsletter; and latterly a parish calendar, but these activities come at a cost - Approx. 10% of annual spend.



CAPITAL WORKS (optional)

These are the lasting investments that OWPC makes in the area such as the improvements at the Patch allotments. In more recent years, delegated budgets of £2k per ward have been established and these have supported additional landscape maintenance and treeplanting; fairy lights at Christmas; bat boxes; and a defibrillator.

Approx 20% of annual spend.

DID YOU KNOW....

For each £1,000 increase to the total £9,104 parish precept there would be an increase of £2.40 p.a. for a Band D property.

So much so that there is currently a significant waiting list for plots, although OWPC parishioners have preference.

Treebilee

To mark the occasion of the platinum Jubilee of Queen Elizabeth II there is an opportunity to plant a number of trees in support of the Queen's Green Canopy project. In partnership with the Woodland Trust, a range of 'tree packs' from 15 to 400 saplings are being made available for free to Parish Councils and community groups. OWPC is exploring possible sites and has identified Lucas Place in Woughton on the Green and the replacement of the missing Rowan Trees as one option. The trees would compliment our existing Jubilee trees including Queen Victoria's Golden Jubilee Oak tree planted in 1887 between the church and pub (pictured circa 1939) and the Coronation Cherry trees along The Green planted in the 1950s.
