# **Editorial**



So here we are again, in the deep Mid-winter and hurtling towards the festivities. Yet there is a rather reflective mood as the year draws to a close, with the nation seeing uneven economic growth. We know that in the parish too, whilst many neighbours continue to thrive, others face starker choices about their spending priorities.

OWPC itself has not been immune from these decisions and, as you know, Old Woughton News has been carrying centre-page articles through the year about the council's budget – how it's raised, managed and spent to meet local requests. In a unique moment in our history, the parish council has decided to recommend a small increase in the Precept, which funds our activities. Nothing of much consequence in the scheme of things (36p per calendar month for a Band D property), and quite an achievement that it has taken 10 years of tight controls before this point has been reached. There is an opportunity to talk with councillors about these proposals over a mince pie at the Annual Parish Meeting at 7pm on 6th December – remaining copies of the 2022 calendar will also be for sale on the night, if that helps your decision as to which size you'd prefer (see p.8).

Also, on the centre pages is Charlotte's first annual review of OWPC activities since she became Chair elect last November. It makes for interesting reading and it is clear that she is never so much at home than when she is at work as Old Woughton's chief custodian. No surprise then that Charlotte was a 'Women of Action' award winner at MK Soroptimist's centenary event this year – congratulations Chair!

Another action woman features on page 6, where the new Clerk – Charlie Davies – introduces herself and why she was attracted to the OWPC role. We wish Charlie every success and look forward to working with her in the years ahead.

That's it for now, other than to promote Cllr. Wilson's fine Christmas colouring page (p.7). With the dramatic arrival of a global pandemic we could not meet for our normal public Annual Parish Meeting in 2020. So, this is a condensed reflection of the last 20 months and the issues, decisions and challenges we faced during this period:

Our first focus then was to find the best way we could communicate as a group and so we quickly subscribed to Zoom as delivering the safest and most economical platform to give us the tools to function. It was also a legal way to hold our formal parish

We also recognised that we needed to deliver information and support through other forms of communication and that every here to help. So, we embarked upon a series of hand delivered leaflets ensuring that all of our residents had contact details and signposted support to ensure that no-one felt addition, we populated our website, expanded the Notification Service and refreshed our noticeboards regularly with the latest guidance and

We also recognised the need for practical help and so a network of volunteer 'buddy' neighbours was set up to assist with food deliveries medicines; and 'Talk and chat' telephone support. Some of our Councillors even signed up to volunteer with NHS. Our amazing community drew together to clap make masks; bags and so much

Our long-standing Chair and Clerk both retired raising significant governance practicalities. An interim Chair was appointed and a 'remote' and virtual recruitment campaign put in place to engage a new Clerk. We turned to our neighbours and the highly qualified Clerk from Broughton & Milton Keynes Village PC - Vicky Mote came forward to support and guide us and continues to do so today - with our thanks!



# **JUNE 2021**

Our community voice was heard in the first 5G Mast planning application process, leading to a Refusal. Like many, OWPC recognises the need for connectivity, but sought a better location. Our Summer Newsletter delivered the residents survey, as we continued to develop a draft budget for 2022/23, whilst considering the Precept decisions we would need to make early in 2022. Our newly-appointed Clerk stepped down due to personal circumstances.



# SEPTEMBER 2021

# **MAY 2021**

May 2021 elections. A term of office is normally 4 years, but due to the pandemic this was elongated to with elections due again in 2024. Then we faced the challenges of carrying out meetings without the use of Zoom as those emergency Regulations lapsed and public meetings had again to be held - adhering to COVID

# **NOVEMBER 2021**



A draft budget is now prepared with 2022/23 (see opposite). An exhaustive consideration of all budget lines has been conducted, but uncertainties remain (eg insurance premium where training for our new Clerk, whilst being equipped to embrace any opportunities such as the devolved landscaping discussions between MKC

# **Decision time**

### **BACKGROUND**

Articles in the Spring and Summer newsletters explained in detail the finance history of your Parish Council.

In summary, large reserves were accumulated in OWPC's first year, 2012/2013, when MKC set our precept at the level of Woughton Community Council of which we were previously a part. In the second year the precept was just halved as we waited until the pattern of regular operational spending became clearer and we learned how to manage the parish effectively before making a drastic cut.

In 2014/15 a precept of £9,103 was set, the aim being to cover regular operating expenditure and for capital projects to be funded out of the reserves. There has been no increase in the precept. Since 2014/15, inflationary rises have seen these annual costs rising to above £13,000 and with no increase in the precept, these increases have been subsidised from our reserves.

### **CAPITAL SPENDING**

In the early days new or refurbished notice boards were provided and we made a much needed investment in the Patch allotments. However we were under intense pressure by the auditors to reduce our reserves and there followed the allocation of a budget to each of the wards to spend for improvement projects.

### **RESERVES**

OWPC decided to aim for a reserves figure of about £18,500, a figure which would be in line with the auditor's demands.

### **CURRENT SITUATION**

The subsidy for our annual operating costs has now reached approximately £5,000 p.a. and reluctantly we must now start to increase the precept each year until we reach the point at which we at least cover those annual operating costs, plus any capital expenditure we wish to fund. The route we are considering will mean we will be able to fund capital projects to the tune of an average of £2,000 p.a. while heading towards a closer balance between precept and expenditure.

### THE PROPOSAL

We propose to raise the precept by 20% each year, probably for the next four years.

For a Band D property the precept would rise to £26.20 (increase of 36p/month), rising to £45.27 in 2025-26 (a total increase over four years of £1.95/month).

# SO, HOW DID WE GET HERE - AGAIN?

In the Finance Team's Explainer (above), we are reminded that on its creation in 2012, OWPC inherited funds of £59,931 from its predecessor body Woughton Community Council. A cautious approach to expenditure was operated until the new parish council had a clear grasp of its liabilities – particularly in respect of the Patch Allotments. Accordingly, in the next two years there were staged reductions in the precept down to £9,103 and there has never been an increase. Nonetheless, comments by the Auditor were routinely made about the size of the remaining Reserves. In 2018, therefore, OWPC decided to establish small Ward budgets to facilitate local projects in each of its four wards and these have proved popular with ideas still coming forward, even though the Reserves have been reduced as planned.


So, what is to be done now? Through parish councillors' many face-to-face exchanges with local residents, through formal PC meetings and specific feedback as recorded through this year's Parish Survey, OWPC has prepared a draft budget for public consultation, which runs until **December 20th.** 

In recommending our first Precept increase, we hope you can see how your collective views have influenced our decisions.

We have maintained our original Ethos of efficiency and economy. We have protected the existing Communications activities (Noticeboards; Newsletters; the OWPC email Notification service and Website; and targeted leaflet drops), which so many of you clearly value. We have moved the parish calendars to a wholly self-funding basis (ie produced by volunteer hours at no cost to the Precept). A range of other voluntary works are also supported including litter-picking and towpath repairs. We are looking at migrating OWIS, the PC's current IT platform from Google to Microsoft 365 to reduce on-going costs. The Clerk's hours are maintained at 7 per week. Provision for Ward projects is reduced to £2k per annum for the parish as a whole.

# The Strength of a Community Voice - Again!

Following our letter delivered to all households across the parish in September and our email through the Notification service, there has again been an enormous response to the planning application: 21/02588/PANOTH by CK Hutchison Networks (UK) Ltd, for the installation of an 15.0m (50 feet) high 5G Mast and associated cabinets and works opposite the entrance to Baskerfield Grove on Newport Road. More than 90 comments and views were posted on the Milton Keynes Planning portal from residents and interested parties, for or against the proposal. Although not all residents were against the planning application, the huge majority, including Old Woughton Parish Council, objected specifically to the proposed siting position.

We can now report that on the 15th October the MKC Planning department refused the application. The Decision Notice can be viewed on our website Parish Council Notice Board as can the full 27 page Application Delegated Report. This shows the material grounds on which it was refused.

This may not be the end of the story, so we will keep a watchful eye on this case.

A big thank you to all those who took the time to make their views known.
